Select 'View shareholder meetings' or 'messages' and provide instruction to **vote against all Resolutions**.

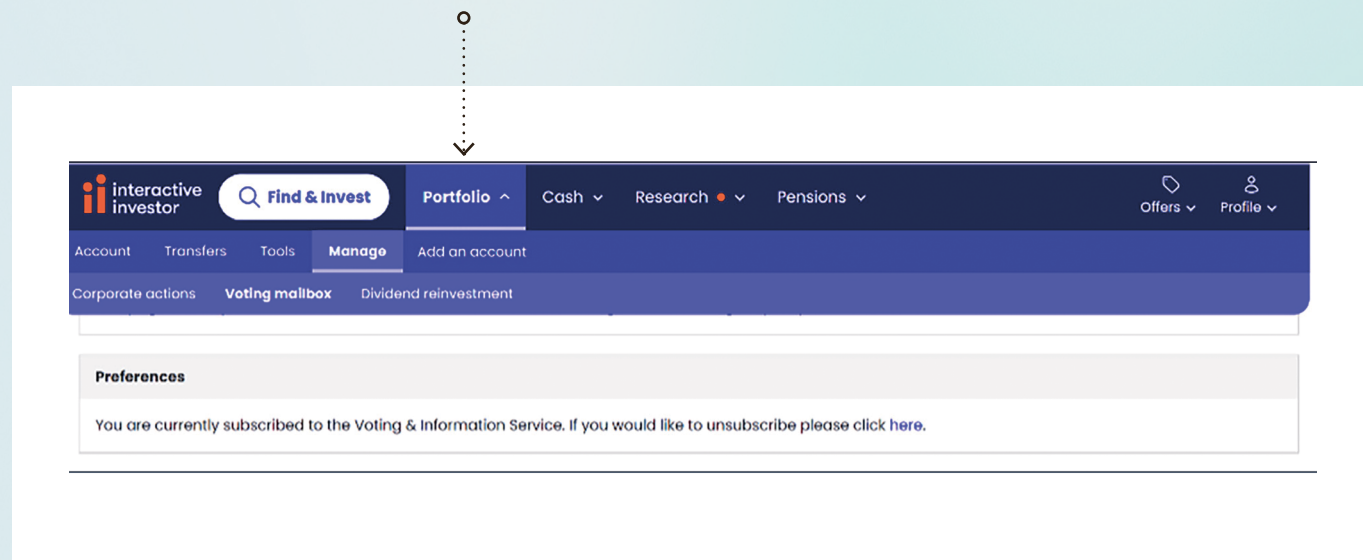

You will need to log in to your AJ Bell account via desktop PC. Please note that instructions cannot be submitted via the AJ Bell app. Select “Voting Instructions” from your account menu. Review your shareholder meetings and choose to submit an instruction to **vote against all the Resolutions.**

Halifax Share Dealing (HSDL)

Deadline – 28th January

Log into your HSDL account online or in the app, select 'Corporate Actions' then 'Notifications' to **vote against all the Resolutions.**

You can also call 0345 722 5525.

Barclays Smart Investor

Deadline – 23rd January

You will need to log into your Barclays account and send them a secure message to **vote against all the Resolutions.**

You can also call 0800 279 3667.

HSBC

Deadline – 23rd January

You can either call the share dealing help desk or send a secure message from your online share dealing account to submit an instruction to **vote against all the Resolutions.**

You can call HSBC on 03456 080 848.

Fidelity

Deadline – 24th January

Log in to your online account (via desktop PC) and select 'My Accounts; from the top-right menu bar. Go to 'Profiles' then 'Preference centre' and select the 'Shareholder voting & information'. Turn on the service by clicking the tab from 'off' to 'on'. Within two working days, you will receive an email from Broadridge with instructions on how to vote. This will include a one time passcode and activation instructions. Once in the portal, you will be able to view the details of the General Meeting.

Alternatively, you can call Fidelity on 0800 414161.

Charles Stanley

Deadline – 24th January

You will need to send Charles Stanley a secure message via your online account (desktop PC) with your instruction to **vote against all the Resolutions.**

You can also call 0207 739 8200.
