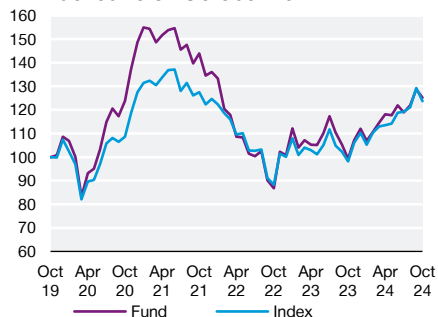

Investment proposition

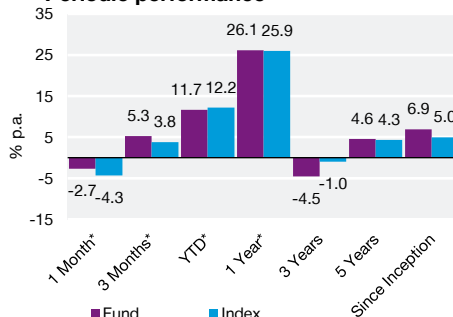

Performance overview – US dollars - Past performance does not predict future returns

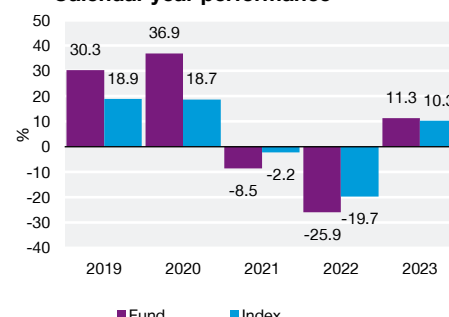
Indexed to 31 October 2024

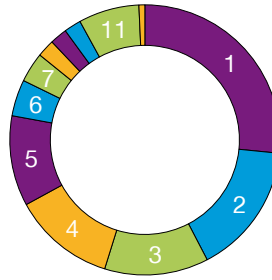
